



Baia Holiday offers to the customers, who included the Travel Safe Guarantee in their booking, the All Risks Assistance to cover penalties for withdrawal from the contract for reasons not covered by the Travel Safe Guarantee, exclusively by issuing a coupon.

A) OBJECT:

The All Risks Baia Holiday's Assistance covers, exclusively through the release of a coupon (voucher), the cancellation fee and/ or deposit charged by the Structure to its customers, under the conditions and limits (exemptions) provided for in point B of this Regulation. The Assistance, effective only in the contracts with included the Safe Travel Guarantee, starts from the date of "booking confirmation", if validated by deposit/ balance expected, and ends 15 days before the scheduled check-in date. It operates only if the customer waives for reasons not covered by the Safe Travel Guarantee.

B) CHARGES TO BE PAID BY CUSTOMERS

With regard to Baia Holiday All Risks Assistance, the following expenses will not be covered by the Coupon / Voucher:

- a) Reservation management fees
- b) Cost of the Travel Safe Guarantee and, if applicable, the cost of All Risk Baia Holiday Assistance
- c) Costs related to ticketing (ferry tickets, airplanes, etc.), as well as costs related to transfers.

The issuance of the voucher will also be subject to the application of the following deductibles:

From 29 to 15 days before the arrival date	50% (With a minimum of € 70)

Travel Safe Premium Guarantee included in the booking practice Maximum Coupon / Voucher € 5.000

DAY OF CANCELLATION	DEDUCTIBLE
Up to 30 days before the arrival date	10% (With a minimum of € 70)
From 29 to 15 days before the arrival date	50% (With a minimum of € 70)
From 14 days before the arrival date	100% (no coupon / voucher can be issued)

Calendar days are considered starting from the day following the date of dispatch, excluding the expected arrival day at the facility.

C) HOW TO REQUEST THE COUPON / DISCOUNT

The cancellation request with coupon / voucher release must be sent to Baia Holiday in writing to **coupon@baiaholiday.it** and must be accompanied by:

- personal data, tax code and contact details;
- reference of the reservation affected by the cancellation;
- rationale for renunciation

The cancellation request with the release of a Baia Holiday coupon / voucher to cover the penalties charged, excludes the possibility of requesting a refund through the Secure Travel Guarantee (and vice versa).

EXCLUSIONS:

No coupon / voucher is provided for cancellations relating to the following types of mobile homes: Sunlodge, Villantent and Mobile Home I. Costs relating to transport / transfer services are also excluded from the Baiaholiday Coupons / vouchers, even if purchased as a related service to the package.

D) COUPON / VOUCHER REDEMPTION METHOD

The customer must communicate in writing to the address **coupon@baiaholiday.it** the redemption of your coupon / voucher indicating also:

- Name and Surname of the holder
- Code of the Coupon / Voucher in your possession
- New check-in and check-out dates requested
- Characteristics of the reservation (type of accommodation, number of people, extra services requested, etc.).

Baia Holiday will send the best available offer (excluding promotions relating to specific payment methods).

The coupon / voucher can never be divided, and the amount of the new booking must be equal to or greater than the value of the coupon / voucher itself. No reimbursement is foreseen in case of partial use of the coupon / voucher and / or for requests / requests for cancellation beyond the terms present in point B.

The coupon / voucher issued by Baia Holiday can be used for a new booking on any Baia Holiday structures until 31 December of the following year of the coupon / voucher's release.

The coupon / voucher can only be used for the balance of the new booking, therefore following the deposit or residual payment due.
